

Corporate Members

1. BSR maintains an open membership policy – refer to our [FAQ page](#) to learn more.
2. Corporate members can maximize their membership by extending their benefits to their fully-owned subsidiaries or select portfolio companies.
3. Eligible companies can join at any time during the calendar year, and dues are renewed annually based on total consolidated annual revenue from the most recently completed fiscal year with available, audited financial statements, per the table below.

Annual Revenues	Annual Dues
Less than US\$5 billion	US\$20,000
US\$5 billion - less than US\$10 billion	US\$25,000
US\$10 billion - less than US\$20 billion	US\$32,000
US\$20 billion - less than US\$50 billion	US\$40,000
US\$50 billion or more	US\$47,000

Spark Members

1. Spark membership is an invitation-only opportunity for existing BSR members. It provides expanded member service and benefits, delivered by a dedicated support team led by a senior BSR executive, and special advisory service rates.
