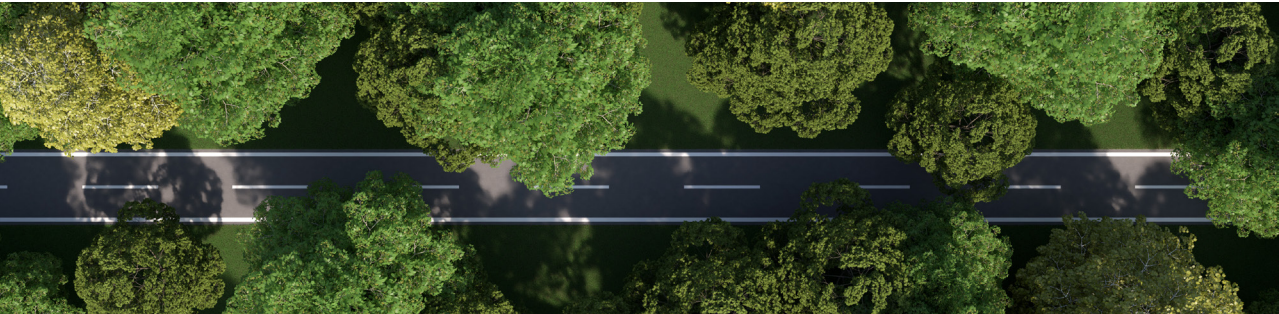

- **Identify and prioritize strategic focus** areas based on business strategy, stakeholder expectations, and planetary and social impacts. Identify tradeoffs, tensions, and interconnected issues
- **Design strategy framework** for key pillars of the sustainability strategy, reflecting its vision and how it supports the business strategy
- **Conduct benchmarking** on key issues that inform ambition levels
- **Determine ambition levels**, areas of strategic focus, and target audiences
- **Establish goals and targets, identify key activities and milestones, and KPIs** to measure success
- **Design governance structures** and recommend the assignment of resources and responsibilities
- **Train internal stakeholders and/or board members;** support internal engagement and communications; engage critical external stakeholders and support with partnership development; develop tracking tools to evaluate performance
- **Understand stakeholder expectations** and validate/test with key business functions
- **Enhance resilience by applying strategic foresight** and stress testing strategy against plausible future scenarios
- **Conduct strategy review**
